Form 990, Part VI, Line 12c - The Organization, on an annual basis, asks each member of the Board of Directors to review the Conflict of Interest Policy to verify that they do not have any conflicts of interest with the Organization.

Form 990, Part VI, Line 15a - The compensation of the Executive Director was reviewed by the Budget and Finance Committee and approved by the Board of Directors as part of the approval of the annual budget.

Form 990, Part VI, Line 18 - The Organization's Form 990 will be mailed to anyone who requests a copy of the form.

Form 990, Part VI, Line 19 - The Organization's governing documents, Conflict of Interest Policy, the annual Audited Financial Statements and the Form 990 are made available to anyone who requests the documents.
